Outcomes and evidence requirements

Outcome 1

Demonstrate knowledge of the audiology referral process for babies.

Evidence requirements

- 1.1 Situations in which a baby is referred to audiology are described in accordance with the National Policy and Quality Standards.
- 1.2 Procedures for referring a baby to audiology are described in accordance with the National Policy and Quality Standards.

Range referral type, correct person, time, referral.

Outcome 2

Demonstrate knowledge of habilitation and intervention options for babies with hearing loss.

Evidence requirements

- 2.1 The role of the audiologist is described in terms of the assessment, diagnosis, and intervention options.

Range options may include but are not limited to – identifying, treating, monitoring.

- 2.2 The role of a Ministry of Education Advisor on Deaf Children (AoDC) and the services an Advisor provides are described in terms of the habilitation process.
- 2.3 Services and organisations that can assist and advise parents are described in terms of the advice and/or assistance that they provide.

Range evidence is required for two services or organisations.

- 2.4 Intervention options are explained in terms of their nature and purpose and how they are developed.

- 2.5 Habilitation options are explained in terms of how they can aid babies with hearing loss.

Range options include – hearing aids, cochlear implants, sign language.
